The successful candidate will be a member of the Environment and Regulatory team and will be responsible for the coordination of the annual field-testing programs. The position will be based in Obsidian Energy's Calgary office but may require occasional travel to field locations.

Responsibilities

Duties include the following, but are not limited to:

- Confirm and compile corporate annual field program lists (D-13 Inactive Well, Isolation Packer Testing, Annual Subsurface Pressure Testing and Surface Casing Vent Flows) to meet regulatory requirements and internal goals;
- Coordinate work with field staff and vendors;
- Submit accurate and timely completed inspections and testing;
- Coordinate data and information gathering in response to related audits;
- Report SCVF, casing and packer failure; track repair deadlines and submissions;
- Report compliance to management;
- Coordinate pressure tests required from other companies for pools assigned to Obsidian Energy as Coordinating Operator;
- Track initial pressure test requirements; coordinate submission with technical staff;
- Collaborate with various internal groups concerning non-compliance events/regulatory
 requirements and voluntary self-disclosures when responding to governing bodies; advise on
 regulatory compliance implications and changes in regulations/requirements as needed;
- Streamline/enhance current processes as needed;





- Provide back-up and support to Environment and Regulatory team as required; and
- Work with internal staff to identify locations without future potential to be reviewed for asset retirement obligation budget programs.
